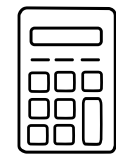

Step 1 - Calculate your family's Per Capita Income (PCI) using the **PCI formula**

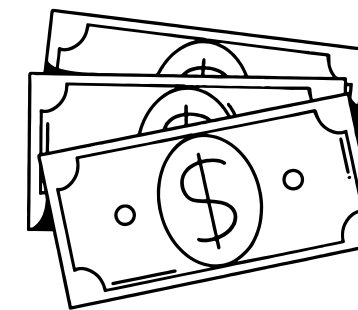


Step 2 - Identify your **Income Tier** in the **left** column of the table on the next page
